AS SURETY, DO HEREBY ACKNOWLEDGE OURSELVES TO BE HELD AND FIRMLY BOUND UNTO THE CITY OF HOUSTON, A MUNICIPAL CORPORATION PRINCIPALLY LOCATED IN HARRIS COUNTY, TEXAS, IN THE SUM OF TWO THOUSAND (\$2,000.00) DOLLARS FOR THE PAYMENT OF WHICH SUM TO THE SAID CITY OF HOUSTON AND ITS SUCCESSORS, WELL AND TRULY TO BE MADE, WE BIND OURSELVES, OUR HEIRS, EXECUTORS, ADMINISTRATORS, ASSIGNS AND LEGAL REPRESENTATIVES, JOINTLY AND SEVERALLY.

THE CONDITIONS OF THIS OBLIGATION ARE SUCH THAT:

WHEREAS, THE SAID PRINCIPAL HAS APPLIED FOR A PERMIT TO ENGAGE IN THE BUSINESS OF CONSTRUCTING SIDEWALKS, DRIVEWAYS, CURBS AND GUTTERS IN THE CITY OF HOUSTON UNDER THE PROVISION OF THE PUBLIC WORKS & ENGINEERING INFRASTRUCTURE DESIGN MANUAL SECTION 10.06D OF THE CITY OF HOUSTON FOR A PERIOD OF LESS THAN ONE YEAR **BEGINNING:**

NOW, THEREFORE, IF THE SAID PRINCIPAL SHALL COMPLY WITH ALL OF THE ORDINANCES OF THE CITY OF HOUSTON PERTAINING TO THE CONSTRUCTION, RECONSTRUCTION, REPAIR OR REGRADING OF SIDEWALK, DRIVEWAYS, CULVERT PIPES, CURB AND GUTTERS AND ALL RULES AND REGULATIONS ESTABLISHED UNDER THE AUTHORITY OF SUCH ORDINANCES, AND SHALL PERFORM ALL SUCH WORK DONE BY THE PERSON OR UNDER THEIR CONTROL IN A WORKMANLIKE MANNER IN CONFORMANCE WITH SAID ORDINANCES AND TO THE LINE AND GRADE AS ESTABLISHED BY THE CITY ENGINEER OF THE CITY OF HOUSTON, AND SHALL INDEMNIFY AND SAVE HARMLESS THE CITY OF HOUSTON AND ALL OTHER PERSONS AGAINST ALL ACCIDENTS AND DAMAGES CAUSED BY NEGLIGENCE IN PROTECTING HIS WORK, OR ANY DEFECTIVE OR UNSILLED WORK DONE BY THE BOND HOLDER OR THEIR EMPLOYEES, THEN THIS OBLIGATION SHALL BE VOID, OTHERWISE THIS BOND SHALL REMAIN IN FULL FORCE AND EFFECT UNTIL THE END OF THE PERIOD SET OUT ABOVE; PROVIDED, THAT SUCH TERMINATION SHALL NOT DISCHARGE NOR RELEASE THE PRINCIPAL OBLIGOR AND THE SURETY HEREIN FROM THE PAYMENT OF CLAIMS AND THE LIABILITY THEREFORE BASED UPON BREACH OF THE CONDITIONS OF THIS BOND OCCURRING PRIOR TO THE TERMINATION HEREOF.

THIS BOND AND ALL OBLIGATIONS CREATED HEREUNDER SHALL BE PERFORMABLE IN HARRIS COUNTY, TEXAS.
